

Dimensioning and protection of drinking water

Make sure there is sufficient allowance for dimensions in line with DIN 1988 section 300 and EN 806-3. DIN 1988 section 100 (protection of drinking water; preservation of drinking water quality) and EN 1717 (protection of drinking water against contaminants in drinking water installations) are to be observed.

Water qualities

SCHELL fittings are suitable for use in drinking water systems in accordance with the current German Drinking Water Ordinance.

Depending on the system, there are sensitive parts within the fittings that need to be protected against dirt particles and limescale deposits. If necessary, back-wash filters and decalcification systems are to be provided (water upwards of 10° dH). All products from Schell can be used with all potable waters in accordance with the EU Drinking Water Directive. Applicable national regulations about general partial water softening for drinking water must be observed.

General installation instructions

Use corrosion resistant pipe materials. Only seal threads with permitted sealants. Do not exceed standard torque!

Protection against legionella

Measures must be taken to protect against legionella in accordance with the standards listed above. SCHELL electronic taps can support this by means of automatic stagnation flushing. In the case of rarely or irregularly used taps, care must be taken to ensure that stagnation flushes with a sufficiently long flush duration and closely timed flush interval are used in order to completely guarantee the water change in the system required by the standards. In the event of service interruptions, various measures must be implemented at the beginning and end depending on the duration (see VDI 3810).

Special attention must be paid to installations for people with immune deficiencies.

Notes on start-up

Before start-up, all pipes must be flushed in accordance with the ZVSHK worksheet, DIN 1988-200 or EN 806-4. Each fitting must be subjected to a leak test after installation. If possible, carry out the pressure test with compressed air.

Instructing the operator

Instruct the operator in accordance with VDI 6023.
